DISCUSSION AND POSSIBLE ACTION REGARDING THE FLOOD PLAIN ORDINANCE:

Motion made by Trustee Butendorf to approve the enactment of the Floodplain Ordinance. Seconded by Trustee Perrault. Unanimously approved.

DISCUSSION AND POSSIBLE ACTION REGARDING THE PAYMENT OF \$3,750 TO THE CITY OF OCONOMOWOC IN 2024 REGARDING OUR SHARE OF EXTENDING THE PUBLIC PIER:

President Clark updated the Board regarding the public pier in front of the Community Center. City has purchased two new piers at a total cost of \$17,000. City is covering \$10,000. Town of Oconomowoc and Village of Lac LaBelle will split the balance. In closed session this was discussed. Trustee Butendorf made a motion to approve the payment of \$3,750 to the City of Oconomowoc in 2024 regarding its share of extending the public pier. Seconded by Renner. Unanimously approved.

VILLAGE ROAD MAINTENANCE UPDATE WITH VILLAGE ENGINEER:

Village Engineer Mickelson updated the Board concerning infrastructure and maintenance budgeting. Worst case scenario would be \$500,000 for the replacement of the pipe in the sewer system for the Village's portion. 7,000 feet of pipe to be replaced. Village Engineer Mickelson updated the costs for fixing the roads in the village.

ITEMS FOR INCLUSION IN 2024 BUDGET: ACCOUNTING SOFTWARE, RECORD RETENTION, SPEED CONTROL SIGNS, OTHER:

President Clark updated the Board. Chief Wraalstad will get numbers for the photo taking speed signs.

CITY BOAT LAUNCH UPDATE, DISCUSSION ONLY.

President Clark updated the Board concerning the cost of the City boat launch. The cost is estimated to be \$2.9 million. The City of Oconomowoc has received a \$1 million grant from the DNR. Village's share per President Clark is no more than 3 percent of total of things that pertain to the Village.

FIREWORKS FUNDING UPDATE: DISCUSSION ONLY.

Trustee Butendorf updated the Board concerning the 2023 fireworks. \$36,909 was raised. The fireworks cost was \$30,000. The Village had a one-time contribution that won't be duplicated next year of \$10,000. Trustee Butendorf proposed July 6th, 2024 a Saturday for fireworks next year.

CHANGING FROM A FULL FINANCIAL AUDIT TO A REVIEW. DISCUSSION ONLY.

President Clark updated the Board concerning an audit versus a review. Discussion had amongst board members.

PROCESS TO EVALUATE PROPOSALS FOR SAEGER EAST. DISCUSSION ONLY.

President Clark is recommending that the Board put out a firm date if there is a proposal for Saeger East and make it an end date. Discussion had amongst Board members.

OPTIONS FOR THE FUTURE OF THE VILLAGE. DISCUSSION ONLY.

President Clark updated the Board in light of the Clerk's resignation. Discussion had amongst Board members concerning back up for certain positions in the Village.

VILLAGE ADMINISTRATOR'S REPORT:

Village Administrator Stumpf updated the Board concerning sewers. Extensive discussion concerning costs for sewer pumps and other sewer maintenance.

Motion made by Trustee Butendorf to adjourn. Seconded by Trustee Perrault. Unanimously approved.
